This Privacy Policy applies to the services offered on www.asteronlife.co.nz offered by Asteron Life Limited. Please read this Privacy Policy carefully before using this website. (It should be read in conjunction with our Terms of Use).



You agree that by using our website you consent to us:

- (a) creating a database record about you if you disclose your personal information to us/register on our website;
- (b) collecting, using and disclosing personal information about you for the purposes of providing financial products and services to you in the manner set out in this Privacy Policy and our relevant Privacy Statement. Unless you have asked us not to send you marketing information, including information (refer to section 5 of this Part B): and

We are committed to safeguarding the privacy of our customers and advisers. We appreciate that as our customer or an adviser, you trust us with your personal information.

In handling your personal information, we will comply with the Privacy Act and, where relevant, the policies and codes of industry groups to which we belong.

This policy explains our general practices in handling personal information. If you need further information, have questions about our privacy practices or wish to gain access to your personal information, please contact us.

2. Collecting personal information

We collect personal information about you and your customers for the purposes set out in our Privacy Statement of providing marketing information, including providing and administering our products and services. For example, we collect information to assess and decide on what terms (if any) we accept your application or increasing or amend your existing insurance, provide and manage the insurance you have after we have accepted the risk and investigate, and if covered, manage and pay any claims made in relation to insurance you have with us.
